FOR RETIRED CERTIFIED LAW ENFORCEMENT OFFICERS  
TO APPLY FOR FIREARMS QUALIFICATION  
IN ACCORDANCE WITH 18 USC, 926b AND 926c**

**YOU MUST:**

1. Complete POST Form 9
2. Include a copy of your ALABAMA Drivers License
3. Include a copy of your photographic identification issued by the law enforcement agency from which you retired
4. Submit this page together with POST form 9B to:

I, \_\_\_\_\_, certify that I am over eighteen years of age and competent to testify. I swear or affirm under the penalties of perjury that I am truthfully answering all the following questions:

- \_\_\_\_\_ I understand that in order to carry a concealed firearm as a qualified retired law enforcement officer in accordance with 18 U.S.C. 926B and 926C, I must satisfy certain basic criteria. My satisfaction of some of the certification criteria will be established based on my answers to these questions.
- \_\_\_\_\_ The law enforcement agency from which I retired has issued me a photographic identification.
- \_\_\_\_\_ I retired in good standing from a public agency as a law enforcement officer.
- \_\_\_\_\_ I retired from the \_\_\_\_\_ (Agency), located in \_\_\_\_\_ (city), \_\_\_\_\_ (state) \_\_\_\_\_ (certification number).
- \_\_\_\_\_ I did not retire for reasons of mental instability.
- \_\_\_\_\_ I was authorized to engage in or supervise the prevention, detection, investigation or prosecution of, or the incarceration of any person for, any violation of law, and I had statutory powers of arrest.
- \_\_\_\_\_ Before retirement, I was *either* (check one):
- \_\_\_\_\_ regularly employed as a law enforcement officer for fifteen (15) or more years aggregated, *or*
- \_\_\_\_\_ I retired after completing probation due to service-connected disability as determined by the agency I retired from.
- \_\_\_\_\_ I have a non-forfeitable right to benefits under my agency's retirement plan.
- \_\_\_\_\_ I am not now under the influence of alcohol or another intoxicating or hallucinatory drug or substance, I am not currently in drug or alcohol rehabilitation and I will not carry a firearm while I am under the influence of alcohol or another intoxicating or hallucinatory drug or substance.
- \_\_\_\_\_ I am not prohibited by federal law from receiving a firearm.
- \_\_\_\_\_ I understand that the definition of "firearm" does not include any machine gun, firearms silencer, or destructive device.
- \_\_\_\_\_ I understand that I must meet the State of Alabama's standards for training and qualification for active law enforcement officers to carry a firearm of the same type as my concealed firearm.
- \_\_\_\_\_ I understand that I must carry the State of Alabama's certification, along with the photographic identification issued by my agency, when I carry the concealed weapon.
- \_\_\_\_\_ I understand that my certification expires twelve months from the date of issue.
- \_\_\_\_\_ I understand this authorization applies only to the weapon-type with which I qualified.
- \_\_\_\_\_ I intend to fire a \_\_\_\_\_ (type) \_\_\_\_\_ (model) \_\_\_\_\_ (caliber) handgun for qualification.
- \_\_\_\_\_ **I understand that the State of Alabama's certification does not give me any rights whatsoever to exercise law enforcement authority or take police action under any circumstances.**
